

# **Collas Crill marks 80th anniversary of Liberation Day**

#### May 2025

To mark the 80th anniversary of Liberation Day in Guernsey, Collas Crill assembled, packed and handed out 500 hampers to those islanders who remained in Guernsey during the occupation or who were evacuated during the Second World War.

Collas Crill has proudly supported the State of Guernsey with this initiative for three consecutive years.

Reflecting on the firm's involvement, Senior Partner Jason Green said: 'This is the third and final year Collas Crill has been involved in this initiative and it's one that I have been particularly proud to have supported.
