Of his appointment as Senior Partner Jason said: 'I am thrilled to start this new chapter of my professional life at Collas Crill. I am looking forward to being involved in the strategic decision making for the firm but also doing my best to raise the profile of the firm and supporting our partners, lawyers and support staff in their day to day lives at Collas Crill.'
