Christian Hay, partner and head of the Guernsey dispute resolution practice, said: "Our Guernsey, Jersey, Cayman and BVI litigation teams have grown by at least 25 per cent in the last 12 months. While some firms are reporting dwindling levels of litigation, the lion's share of our growth over the last few years has been in litigation and dispute resolution.

"Increasingly, our litigation teams are working with institutional clients in both the non-contentious and semi-contentious advisory space – particularly in matters relating to insolvency, trusts and financial services regulation.

"We have acted for clients in all of the recent high profile matters that have come before the offshore courts, including Carlyle, Tchenguiz, Crociani, Ocean Rig, Platinum Partners, and Abraaj Holdings.

"These senior promotions in Guernsey, Jersey and Cayman, together with Rocco's appointment and the recent recruitment of partner Gerard Clarke in BVI, evidence that litigation and dispute resolution remains very much one of our key strengths."
