



# LEGAL 500 UK RANKINGS

## OCTOBER 2020

Collas Crill has been recommended as a top tier firm in four practice areas in Guernsey and Jersey in the Legal 500 United Kingdom 2021 rankings, reflecting the quality of work, clients and lawyers in these fields.

Five of the firm's practice areas moved up a tier including the dispute resolution team in Jersey, jumping in the rankings to claim its place in Tier 1, alongside the firm's Guernsey dispute resolution team.
